
25 billion € value added to EU GDP

39% packaging paper & board



Raw Materials Use in Papermaking



European Business Environment



Paper Industry operates in a highly regulated business environment:

- Particular focus on environmental protection (IPPC, Kyoto,...)
- Increasing understanding for competitiveness?
- Weaknesses:
 - High labour cost and
 - Increasingly high energy cost
 - Real performance not well known?
- Strong points:
 - Knowledge base and
 - Availability of recovered paper

Taking producer responsibility: European Declaration on Paper Recycling 2006-2010


- Voluntary industry commitment
- New opportunities
 - Focus on quality meeting higher requirements
 - Eco-design for recyclability
 - Political trust increased

By 2010
Over 2000 kg of paper is recycled each second in Europe!

- ➤ Making Paper Industry Success Story known?




Global situation: Paper consumption

Clear correlation between paper consumption and income: paper consumption will grow an estimated 4.5% pa in Eastern Europe.
